OPENING:

Kay Keeland, Co-President, called the meeting to order at 5:00 p.m.

Margaret Arnold, Personal and Professional Enrichment, gave the inspiration. PROGRAM:



1.) Katherine Grogan then introduced Melanie Rudebeck to share her memories from the McAllen TSO Convention in June. Melanie roomed with Marylin Nease and especially enjoyed seeing old friends from previous conventions, sharing meals with her friends, and making new friends. She stated that the convention felt like home. She also attended the meeting for chapter presidents, which she found helpful. Melanie had never been to McAllen, so she especially enjoyed learning about the city and shopping. She also liked sampling the city's favorite drink, "border buttermilk," which was actually a margarita.

2.) Katherine Grogan next introduced Marylin Nease, who shared her best practices to recruit and retain members. Marylin shared an article that she submitted to the DKG magazine *Collegial Exchange*, and that is based on her membership presentation at McAllen. She stated that the most important one

of the Founders' seven Purposes is Purpose 1, fellowship. Our Founder, Dr. Annie Webb Blanton, knew that the most important goal of DKG was to unite women educators in fellowship, more important than scholarships or instruction on issues affecting education. Although much has changed since the founding of DKG, this Purpose still works and leads members into working successfully on the other six Purposes. Fellowship time might not work in some other countries, or some educators might find joining DKG too costly, so chapters should adapt the ideas as needed. Marylin urged members to share the joy of membership with prospective members and to be welcoming to any new members and members they do not already know. Chapters should schedule time for



fellowship, have inspirational messages and ice breakers, encourage members to sit with members they don't know well, recognize members' birthdays and years of membership, and generally try to learn interesting facts about members they may not know well. New members should be spotlighted in the newsletter, mentored by *all* members, and welcomed with a receiving line after they are inducted into DKG. Encouraging fellowship is the best way to recruit and retain members and grow the chapter.

3.) Katherine Grogan then introduced Leesa Cole to share a big change coming to DKG. A survey was conducted to get members' opinions on proposed changes before announcing them. A convention will be held every other year. On the even years, regional workshops will be held instead of a statewide convention. Our chapter will attend the Northeast Regional Area Workshop, which will be for all chapters in areas 1, 9, and 17. The Northeast Regional Area Workshop will be held on Sat., June 22, 2024, and breakfast and lunch will be included. Lynda Anderson (TSO mentor for areas 1,9, and 17) and the area coordinators for areas 1, 9, and 17 will be leading the planning for this workshop. The workshop will have a lot of similarities to what happens at convention-without a business meeting. The workshop will cost only \$50, and incoming presidents of chapters will have their fees covered by TSO. Janie Wigley, Area 9 coordinator, will be publishing a regular newsletter, which will be sent to all area members with information regarding the workshop. Kay Keeland, Co-President, has signed up Delta Omicron to be in charge of morning snacks.

Of the state convention in McAllen, Melanie Rudebeck said, "I especially enjoyed seeing old friends from previous conventions, sharing meals with my friends, and making new friends." She added that "the convention felt like home."

BUSINESS:

1.) Marta Finlay, Finance Committee Co-Chair, gave the treasurer's report. The bank balance as of Aug. 30, 2023, is \$2,556.83. Income during May through Aug. included dues for 55 members (48 active, 6 reserve, and 1 state honorary). \$90 was added to the chapter speaker fund. Expenses for May through Aug. included dues to International, dues and fees to TSO, president reimbursement for McAllen Convention, member stipend for McAllen Convention, ASTEF contribution for Mary Louise Million's memorial, and ceremonies chair reimbursement. Anticipated Income for Sept. includes dues from new members if any. Anticipated expenses for Sept. include the chapter donation to the Cora McFarland Scholarship Fund, chapter fee to CCDC, and membership chair reimbursement. The Aug. balance closes out all income and expenses for 2022-23. Form 15 annual treasurer's report has been filed with TSO, and the 990n ePostcard annual filing has been submitted to IRS.



- 2.) The Finance Committee and the chapter co-presidents met in Aug. to form the proposed budget for 2023-24. Marta shared changes in the budget from the previous budget. \$30 will be paid to each member who attends the NE RAW, thus requiring members to pay only \$20 to attend. Members can expect to pay \$50 for the CCDC luncheon to cover the cost of the meal and the staff to serve the luncheon. Margaret Thompson questioned an item in the proposed budget regarding dues for new or reinstated members. The dues cost was listed as \$100, but dues have been changed to \$90. Leesa Cole agreed that this item should be changed to \$90. Betty Sue Welch made a motion that the proposed budget be accepted, and Lou McMillan seconded the motion. The budget was approved unanimously.
- 3.) Marylin Nease announced that she now has enough volunteers who are willing to print and mail newsletters to those members who have requested them for vision or technology reasons. Margaret Arnold, Joyanne Burger, and Penni Lewis will each print and mail two newsletters each month.
- 4.) Kay Keeland announced that the chapter will support Melanie's school, The Community School of the Park Cities, this year as the chapter's service project. On Fri., Sept. 29, Kay wants us to take breakfast to staff at the school. Members who accompany Kay will have an opportunity to build up teachers at the school and encourage their work. The school is in a red brick building near SMU. Kay hopes that the chapter can do another breakfast or some other event in the spring.



5.) Betty Sue Welch, Social Arrangements Committee, thanked the hostesses for the Sept. meeting and encouraged those members on the list as hostesses for the Oct. meeting to let her know what they will bring in Oct. Kathy Sutton announced that Delta Rho will be attending the Oct. Delta Omicron meeting, and that they will provide all the paper products needed for refreshments.



ADJOURNMENT:

The DKG song was sung. Penni Lewis, Music Committee chair, asked if any member collected the laminated song sheets from the last meeting after she had to leave early. Margaret Thompson told Penni that she had the sheets. The meeting was adjourned at 6:00 p.m.
