# Delta Omicron, Executive Board Meeting Minutes, August 1, 2020

The Executive Board of Delta Omicron Chapter, Dallas, Texas, DKG Society International, met via Zoom on Saturday, August 1, 2020. Attending were Katherine Grogan, President; Elenora Asbury and Kathy Rodriguez, Co-Vice Presidents for Programs and Projects; Margaret Thompson, Co-Vice President for Membership; Margie Rohde, Recording Secretary; Susan Endicott, Corresponding Secretary; Leesa Cole, Treasurer; Julie Turnbow, Parliamentarian; Lou McMillan, Immediate Past President; and Marylin Nease, Communications and Publicity Committee Chair. All board members were present except Co-Vice President for Membership. Katherine Grogan will get in touch with her to

share what happened at this meeting.

Katherine called the meeting to order at 10:05 a.m.

Katherine presented her proposed **calendar dates for the chapter's 2020-2021 meetings**. After discussion, board members unanimously accepted the following calendar:

All meetings will be via Zoom. The only possible change will be if the date of the luncheon changes. Katherine will check with Carolyn Miller, Coordinating Council of Dallas County Chair, as Carolyn leads the event's planning.

Members next discussed **the need to help members learn how to attend Zoom meetings.** Margaret Thompson will update a call list used for the May chapter fellowship meeting. Board members can use the call list to contact chapter members and offer to practice with them before the next meeting. Board members will report back to Margaret.

Members then considered **program ideas**. Julie Turnbow offered to present an August 17 program on the 100<sup>th</sup> anniversary of women getting the right to vote. Rose-Mary Rumbley has agreed to do a program on laughter. The date of this program is not yet decided. Elenora Asbury and Kathy Rodriquez would like to do a meeting where members share books that they have read over the summer. Marylin Nease suggested that our chapter try using the Texas State Organization plan of involving the Educational Excellence committees in program planning and presenting. The committees would participate in program subjects where they have relevance. The EE committees are Global Awareness (Carolyn Power), Legislation

, Music (Penni Lewis), Personal and Professional Enrichment (Janet Hogg), Research (Marylin Nease), and Women in the Arts (Barbara Clinton). Katherine suggested that an artist, might be an interesting speaker. Katherine will send out an updated list of chairs and members of the various committees, including Personal and Professional Enrichment, our committee responsible for inspirations read at the beginning of each meeting

Leesa Cole gave the **treasurer's report**. There is \$5,722.49 in the bank, although \$712.02 belongs to Area 9. Thus, the actual chapter balance is \$5,005.47. Delta Omicron has 65 members, but five members have not paid their dues despite reminders. If they do not pay by 10/1/20, they will be dropped as members. We hope that they will pay their dues and continue their membership.

Margaret Thompson talked about her **ideas to recruit new members**. She hopes to recruit collegiate members and is thinking about setting up some sort of mentoring relationships with chapter members. Leesa told Margaret that student members pay only \$50, and that \$20 of that money goes to international, and \$7 goes to state. Board members agreed that we will have to be creative in recruiting new members, given that our meetings are on Zoom. Leesa suggested that if Margaret has any ideas that involve money, she should consult with the Finance Committee. Leesa and Margaret agreed to work together on membership. Members also briefly discussed how to do orientation of new members on Zoom.

Marylin Nease reviewed the **Area 9 Workshop** to be held on September 19 via Zoom, and she urged all officers and committee chairs to sign up. Currently, 11 Delta Omicron members are registered for the workshop. 120 total people from Area 9 are registered so far. Members can attend sessions of interest as well as those which deal with their office or committee. The more ideas attendees get from the sessions, the more information they can share with the chapter.

Katherine discussed the **Alliance Stamp Ministry**. A ministry of Nancy Newton, a Past State President, this organization sorts, trims, and sells used stamps to stamp collectors. They use the money raised to make Spanish-language Christian books, "Sunday School" lessons and texts for children in Mexico, Central America, and South America. They have raised \$8,000 in the first five months or so. It is important to leave a margin of ½ to ½ inch around the stamps when cutting them out of the envelope. If members can bring in cancelled stamps, Katherine will see that they get to right person.

Chapter member Kay Keeland has expressed an interest in doing some **community service projects**. After some discussion on how to best use Kay's skills, board members decided to invite her to the next board meeting to further explore her ideas. Marylin suggested that Kay might chair a subcommittee under the Programs and Service Projects Committee, which Elenora and Kathy chair as co-vice presidents.

Katherine offered to supply **door prizes for Zoom meetings**. Her plans are to purchase gift cards and to invite two members per meeting to lunch with her. The Fellowship Committee would administer the door prize program. Katherine also hopes to have icebreaker activities at the start of each Zoom meeting as members are signing in.

Guidelines call for two **board meetings each school year**, one in fall and one in spring. Members decided to hold another board meeting on 10/3/20 at 10:00 a.m. as well as to hold a board meeting in the spring. An important topic of the next board meeting will be how to bring new members into the chapter, especially whether it would be better to bring new members into Delta Omicron in the spring rather than the fall and how much new members should pay if they join in the fall given that they would have to pay full membership again in the spring.

The board **meeting adjourned** at 11:30 a.m.

# Delta Omicron, Chapter Meeting Minutes, August 17, 2020

Delta Omicron Chapter, Dallas, Texas, DKG Society International, met on Monday, August 17, 2020, via Zoom. Attending were 24 members: Sherri Allinder, Elenora Asbury, Maureen Baker, Susan Bell, Barbara Clinton, Leesa Cole, Grace Delatour, Susan Endicott, Marta Finlay, Mary Gill,

Katherine Grogan, Barbara Harris, Kay Keeland, Penni Lewis, Lou McMillan, Carolyn Miller, Marylin Nease, Carolyn Power, Margie Rohde, Margaret Thompson,

Julie Turnbow, and Mary White.

#### **OPENING:**

Katherine Grogan, President, called the meeting to order at 4:40 p.m. Maureen Baker, Personal and Professional Enrichment Committee, presented an inspiration titled "Joy of Persevering." Maureen talked about accepting the deserts (difficulties) in life as well as the joys and about persevering always.

#### **BUSINESS:**

Members approved the February 2020 meeting **minutes** as printed in the March newsletter. Carolyn Power, 2018-2020 **Nominations Committee**, reminded members that the 2020-2022 Nominations Committee needed to be approved. Carolyn stated that Lou McMillan had been nominated to chair the Nominations Committee, and the nominated members of the committee were Barbara Clinton, Leesa Cole, Ginger Gustovich, Melanie Rudebeck, and Wanda Spoonmore. Chapter members made, seconded, and approved the motion to elect this committee.

Leesa Cole, Treasurer, gave the **treasurer's report**. The current bank balance is \$5,722.99, although \$721.02 is money belonging to Area 9. This money was collected for Patti Belknap's reception originally scheduled for March, but postponed until October, 2020. Since Marylin Nease is the Coordinator for Area 9, the money goes through our chapter account. So, the real balance for Delta Omicron is \$5,005.47. Approximately \$3,000 of budgeted expenses, such as for convention hotel and travel expenses, were not incurred because of the COVID shutdown. Dues were paid to International and to TSO for 59 members: 58 active members @ \$3,491.60, 1 reserve member @ \$27.20, and 1 honorary member @\$0 (no yearly dues assessed). There are currently 65 members with five unpaid, who will be removed from the roster if they don't pay by 10/1/20. We hope that these members will pay their dues. Our local bank lobby will be reopening this week, and Leesa and Katherine will update account signers. The Finance Committee, cochaired by Marta Finlay and Mary Gill, will meet 8/28/20 to form a proposed budget for 2020-2021, and chapter members will vote on this proposed budget at the September meeting. Leesa filed required reports in July: Form 15 Annual Treasurer's Report to TSO and IRS 990N ePostcard to the IRS.

Margaret Thompson, Membership Co-Vice President, presented a get-acquainted quiz on facts members shared about themselves at the Zoom fellowship meeting on 8/10/20. The three members presented were Elenora Asbury, a dyslexia specialist; Mary Gill, owner of a cockapoo puppy, and Judy Culbertson, teacher at The Winston School who lovingly described her students as "genius little devils."

Two current **projects** were next on the agenda. (a) Leesa Cole and Katherine Grogan assembled teacher gift bags and helped deliver them to the homes of our chapter's working teachers last week. (b) Kay Keeland, Community Service Projects, stated that members had donated \$240 for North Texas Food Bank so far. Kay and members of her committee will be at Northway Christian Church on Tuesday from 11 a.m.-12 p.m. and Wednesday from 2-3 p.m. to pick up food and money donations from members. Members are encouraged to check an email from Katherine Grogan listing foods the food bank especially needs.

Elenora Asbury, **Programs** and Projects Co-Vice President, announced that Rose-Mary Rumbley will talk about laughter at the September meeting, and that Legislation Committee, will talk at the October meeting about the upcoming elections.

#### PROGRAM:

**Educational Excellence Committee members** presented information about women's suffrage to lead into our program.

**Legislation**, showed a ballot from 1920. She stated that the Democrats had trouble getting a candidate and finally settled on a dark horse, James M. Cox, who was Woodrow Wilson's son-in-law. A Socialist Party nominee was even on the ticket. The winner was Warren G. Harding, a Republican whose slogan was "Return to Normalcy."

Barbara Clinton, **Women in the Arts**, showed slides about women suffragists. One of the first in Texas was Minnie F. Cunningham, who was a librarian and earned a pharmacist degree. She led suffragists throughout Texas. Another was Jane McCallum, who fought for women's education. The colors of the movement were purple, white, and gold. Suffragists wore white to symbolize purity and high mindedness.

Marylin Nease, **Research**, gave the members a series of facts about voting and numbers of women in elected offices. The percentage of eligible women voting is higher than that of eligible men voting. 23.2% of the U.S. House of Representatives members are now women. 26% of the U.S. Senate are women. 18% of our 50 states have female governors. 0% of our U.S. Presidents and Vice Presidents have been women.

Carolyn Power, **Global Awareness**, reminded members that one of the seven purposes of DKG is to inform members of social, education, and legislative issues. She also sends out a newsletter from the US Forum to keep members informed, and she stated that there will be a free webinar on 9/29 at 6 p.m. She encouraged members who have opinions on what is currently happening in schools to participate in the webinar. She also reminded members about our DKG International project Schools for Africa that assists schools in 21 African countries.

Penni Lewis, Music, shared a song from Mary Poppins—"Sister Suffragettes."

Julie Turnbow, chapter parliamentarian and Professor of Mathematics at Collin College, presented a talk on "100 Years of Women's Suffrage in the U.S." Although women did not get the right to vote until the 19th Amendment was ratified on 8/18/1920, New Jersey gave women the right to vote in 1776 if they met certain conditions. In 1848 in Seneca Falls, New York, Lucretia Mott and Elizabeth Stanton organized one of the first women's rights conventions. Susan B. Anthony later joined in the movement. At that time society wanted women to be submissive and to concern themselves solely with their family's needs. Wyoming was the first state to grant women the right to vote while it was still a territory in 1870. Wyoming also had the first woman governor in Nellie Ross in 1925. The 19th Amendment was approved by Congress on June 3, 1919. It then had to be ratified by 36 states. The southern states did not ratify the 19th Amendment. Tennessee was the 36th state. Many Southern states continued to have a poll tax until 1964 as a means to limit blacks and women from voting. Many Southern states also had other restrictions such as requiring women to recite portions of the Constitution correctly before they could vote. Mississippi, in fact, did not officially ratify the 19th Amendment until 1984! Penni Lewis shared her father's experiences when he was in the Texas Legislature in the 1960s and stated that she believed the restrictive rules were eventually overruled by federal legislation in the mid-1960s. Finally, Julie stated that three women have run for vice president of the United States, and two women have run for president.

This year one-punch, straight-ticket voting is no longer an option in Texas. That means we will have to carefully research each candidate on the ballot. Remember Empower Texans still has candidates on the ballot. It is imperative that everyone vote this year because the outcome of this election may decide the future of our country.

#### Please remember these dates:

Oct. 5, 2020 - Last day to register to vote Oct. 23, 2020 - Vote by mail application due

Oct. 13-30, 2020 - Early voting

Nov. 3, 2020 - Election Day

Discussions continue about the potential expansion of TRS offices into other parts of the state, including possibly opening a satellite office in El Paso. Providing better access to retirement counselors was a recommendation by the Sunset Advisory Commission. Understanding why TRS needs satellite
