
"Please put me down to be a hostess in 2022. Hope I'll receive the second vaccine by then."

Penni said Beth volunteered at Network in her later life.

Marta Finlay remembered how Beth **found the perfect person to care for Marta's two daughters** so that Marta would feel comfortable teaching kindergarten with Beth.

Carolyn Power stated that Beth was a master teacher. Carolyn especially remembered the many international trips Beth and Jim took and how she shared her experiences with Carolyn and Penni. Beth created international days in her classroom, always making sure that she tied the activities to kindergarten TEKS. Beth had the children make gifts for Mother's Day. Her classroom always had many animals in it, and the children's families took turns caring for these animals during breaks. Margaret Thompson shared her experience caring for the classroom tarantula. Ceremony #1: Recognition of Years of Service

Margaret Thompson, Membership Vice President, introduced the following members to be honored: Susan Endicott and Melanie Rudebeck, members for 25 years; and Janet Cundiff, a member for 53 years, Shirley Kochman, a member for 58 years, Wanda Spoonmore, a member for 57 years, and Jean Wallace, a member for 52 years. Unfortunately, only Jean Wallace was present for the ceremony. Marylin Nease, Research Committee Chair, gave a presentation on the meaning of the symbols of Delta Kappa Gamma. Our key is a golden ellipse with Greek letters in its center and a wreath of laurel leaves. Below the letters is a cup, which represents knowledge. The coat of arms consists of a red shield with a band of gold. Three Tudor roses on the band symbolize the Society's ideals of friendship, loyalty, and helpfulness. The flaming lamp and the open book on the shield signify scholarship and knowledge. The laurel sprays are the traditional symbols of achievement. Margaret read the Delta Kappa Gamma pledge for members and asked them to silently repeat the pledge.

Ceremony #2: Founders Day

Liza Leggett, Ceremonies Committee Chair, led the **Founders Day ceremony** with help from her committee members. Delta Kappa Gamma was founded on May 11, 1929, by Annie Webb Blanton, Mamie Sue Bastian, Ruby Cole, Mabel Grizzard, Anna Hiss, Ray King, Sue King, Helen Koch, Ruby Lomax, Cora Martin, Lalla Odom, and Lela Williams. **Dr. Blanton wanted to share views on education and methods with other educators worldwide.** In 1933 she was appointed professor at UT Austin. She knew that the status of women and opportunities for women were limited without some changes. She **hoped that DKG would advance the roles of educators so that they could accomplish worthy goals.**

Delta Kappa Gamma has 7 stated Purposes. The first is to unite women educators of the world in a genuine spiritual fellowship. **The second** is to honor women who have given or who evidence a potential for distinctive service in any field of education. **The third** is to advance the professional interest and position of women in education. **The fourth** is to initiate, endorse, and support desirable legislation or other suitable endeavors in the interest of education and women educators. **The fifth** is to endow scholarships to aid outstanding women educators in pursuing graduate study and to grant fellowships to nonmember women educators. **The sixth** is to stimulate the personal and professional growth of members and to encourage their participation in appropriate programs of action. **The seventh** is to inform members of current economic, social, political, and education issues so that they may participate effectively in a world society. Speakers gave examples of each Purpose brought to life in Delta Omicron this past year.

Ceremony #3: Chapter Birthday

Liza Leggett also led the chapter birthday ceremony.

On May 19, 1956, 40 Dallas-area women educators became charter members the Delta Omicron Chapter of DKG. It was the 111th chapter in Texas. The chartering was directed by two past state presidents: Eula Lee Carter and Phyllis Ellis.

We proudly celebrated the 65th birthday of our chapter.

Interview of an Almost 50-year Member

She **taught third and fourth grades while still in Mississippi and loved teaching**. **started several programs to enrich the children's experiences.** The children put on a Christmas program as well as an Easter program for their families. When she was still in Mississippi, she wanted to start a school for disadvantaged children, but that never happened. **taught eight years in Dallas ISD before deciding to become an educational diagnostician. She had to return to school to get certified as a diagnostician**. also started working on her PhD, but never finished the program.

credits her mother with her interest in legislation. Her mother used to stand on street corners to push for reforms she believed in. continues her mother's tradition by getting legislative information to members and pushing for members to vote.

has been married for 20 years to, a retired lawyer.was at one time #3 in theDistrict Attorney's office.hopes that she can convinceto travel more once the pandemic iscompletely over.One of her favorite activities remains skiing.

ANNOUNCEMENTS:

Leesa Cole, Scholarship Committee Chair, stated that **no one applied for the chapter scholarship or the chapter's grant-in-aid**.

The Chapter Achievement Award will be presented next year.

Susan Endicott, Corresponding Secretary, was not present, so Katherine summed up member care and concerns.

NEW BUSINESS:

Leesa Cole, Treasurer, gave the **treasurer's report**. The **bank balance as of Apr. 30 was \$7,195.39**. **Area 9's portion of that amount is \$717.02**, **so the actual balance is \$6,478.37**. Income for March and April includes dues and CCDC Brunch reservations. Expenses for March and April include reimbursement to Membership Vice President, Schools for Africa chapter and member contributions, and CCDC Brunch reservations. Leesa stated that 25 members still need to pay dues, and that dues should be paid by May 30. Leesa will accept either full payment of \$100 or partial payment of \$50. She can accept payment either through mailed checks or via Venmo.

The minutes from the March meeting were approved as printed in the newsletter.

The **DKG Convention in Denton** in June was briefly discussed. Members registered to attend include Leesa Cole, Katherine Grogan, Kay Keeland, Carolyn Miller, Marylin Nease, Carolyn Power, Wanda Spoonmore, and

Carolyn Power had already left the meeting, so Katherine reminded members of the U. S. Forum's May 19 Zoom about "Voting: A Right for Everyone" presented by the League of Women Voters.

Katherine also gave a **brief thank-you to members for all their help in the past year**. She announced that she **hoped the chapter can have meetings in person at the Highland Park Presbyterian Church in the fall.**

Marylin Nease, Area 9 Coordinator, reminded members of the reception for Patti Belknap at the TSO Headquarters on June 5 from 2-4 p.m. Marylin needs to know how many members will attend.

EXECUTIVE BOARD MEETING MINUTES, AUGUST 14, 2021

The Executive Board of Delta Omicron Chapter, Dallas, Texas, Texas State Organization, DKG Society International, met at Katherine Grogan's house on Aug. 14, 2021. Attending were Katherine Grogan, President; Elenora Asbury, Co-Vice President for Programs and Projects; Margaret Thompson, Vice President for Membership; Margie Rohde, Recording Secretary; Marta Finlay and Mary Gill, Finance Committee Co-Chairs; Marylin Nease, Communications and Publicity Committee Chair; and Kay Keeland, Community Service Committee Chair. Unable to attend were Leesa Cole. Treasurer: Kathy Rodriguez. Co-Vice President for Programs and Projects; Susan Endicott, Corresponding Secretary; Julie Turnbow, Parliamentarian; and Lou McMillan, Immediate Past President, Katherine Grogan called the meeting to order at 10:55 a.m. and welcomed attendees.

2021-22 CHAPTER MEETING LOCATION:

Katherine announced that our chapter meetings for 2021-22 will be at Highland Park Presbyterian **Church** in room K on the second floor. She is seeking a church staff member to sponsor Delta Omicron so that we can use the room without a fee instead of renting it for \$50/meeting.

She plans to conduct hybrid meetings by Zoom as needed and asked that the board approve her purchase of a Zoom account for \$160/year. The board approved her request. Katherine already has a document camera to use.

Kay Keeland and Elenora Asbury volunteered to stand outside by the parking garage entrance and at the north elevator to guide members to room K before the first meeting. Board members discussed emailing a simple map to chapter members to help them find the church and parking garage.

PROGRAMS:

a). b). Katherine will talk with Ceremonies Committee members about plans for the May meeting.

c). Elenora plans to have the speakers present programs at the beginning of each meeting with any chapter business to follow.

d). Katherine and members praised Elenora for her work as programs co-chair.

MEMBERSHIP:

a). Margaret announced that there are **two prospective members** nominated by Kay Keeland. **Margaret also hopes to invite** the director of the day school and the director of the day care program at HPPC to join.

b). She suggested that the **chapter have a "bring a friend night"** when all members would invite a friend they think would be a good member. The chapter could do this at the October or November meetings. Margaret **suggested that members consider taking a prospective member out to lunch before bringing them to a meeting** and use that outing to share information about the chapter.

c). Katherine has collected some door prizes for meetings. She also shared star sheets (for member reflections/input) from convention and suggested that they could be used to increase membership. These could be handed out at the September meeting, or Margaret can adapt the idea to use for member input.

d). New members from last year still need their pins. The board **discussed having a ceremony for these new members at the September meeting**. The chapter has already purchased five pins. We need to check induction records for members who need their 25- and 50-year pins. Katherine will talk with the Ceremonies Committee regarding a ceremony.

e). Katherine and members praised Margaret's work on membership.

FINANCE:

a). Marta gave a brief treasurer's report for Leesa: The balance in our account is \$3,939.96. Area 9 money is no longer in the chapter account as Marylin Nease is no longer Area Coordinator and those funds have been disbursed. Marta has list of paid members, which she will send to the executive board. Several checks have not yet cleared. Three members from last year have not yet renewed their membership. Numerous efforts have been made to urge members who have not yet paid to rejoin.
Mary Louise Milliorn has requested her active membership become reserve membership. Katherine suggested that this be voted on at next meeting.

b). Marta discussed using card stock with DKG logo and Delta Omicron name in red for thankyou notes to speakers and other mailings. She mentioned that postage is increasing soon and felt that these in-house-produced cards would be cheaper than buying individual, as needed, commercially produced cards. Susan Endicott could use these DKG-personalized cards for get-well and sympathy cards. Marylin suggested that electronic stationery could be used more; members said they preferred USPS-mailed, paper cards. Marta will get an estimate of the cost of getting card stock printed with DKG logo and name of Delta Omicron.

c). Katherine and members praised Marta and Mary for their work leading the Finance Committee.

COMMUNICATIONS AND PUBLICITY:

a). Marylin needs to update the yearbook, specifically the directory of members, the programs list for the coming year, the awards and honors from convention, and so forth.

- b). She also plans to create the Sept. newsletter.
- c). She will send group emails to members to gather info for the yearbook and newsletter.
- d). Katherine and members praised Marylin for the work she does on the newsletter and yearbook.

COMMUNITY SERVICE PROJECT and FELLOWSHIP COMMITTEE:

a). Kay wants to pick a different school to help this year. One possibility is the West Dallas Community School, where Rose-Mary Rumbley has taught in the past. Ideas to consider are making a donation, selecting a teacher to support, giving teacher bags, serving a meal for the teachers, or tutoring. Another possibility is Notre Dame School, a school for special education children. The board decided to ask if members have any other choices for schools and vote on this at the September meeting.

b). Kay stated that Mary White has moved to Kansas, but she is presently in Dallas for a few days. To honor Mary, Kay wants to have a luncheon with members on Aug. 20 at Jason's Deli. Kay will send an email to members regarding this plan.

c). Kay has talked with Wanda Spoonmore, and they agreed to wait on any more luncheons or social outings until the Covid situation improves.

d). Katherine and members praised Kay for her work with community service projects and fellowship outings.

NEW BUSINESS:

a). Katherine requested that each officer and committee chair record information that might be helpful to future officers and chairs. All members of the executive board received a form to use.
b). Katherine discussed food arrangements for meetings. She felt there was too much food at the last September meeting that was held in person. The board agreed that designating just a few members per meeting and designating refreshment types and servings to bring might work better. Cindy Dominquez, Social Arrangements chair, is responsible for planning hospitality at meetings. Katherine, Kay, and Cindy will have lunch to discuss plans, specifically to alphabetically divide our membership and assign them to specific meetings to bring food.

c). Katherine needs our membership list, programs list, and executive board meeting minutes by Aug. 20, as she has the Area 9 Presidents' meeting Aug. 21.

Katherine **adjourned the meeting** at 12:40 p.m. Members enjoyed lunch and fellowship. **Members thanked Katherine for her leadership as president and her hospitality as meeting hostess.**

Note: For the conference's community service project, attendees and their chapter members contributed hardback children's books.


